Students graduate from the Non-Thesis Master’s Program in Public Law upon the successful completion of a total of 90 ECTS credits, consisting of at least ten courses—one of which is the course titled Scientific Research Methods and Ethics—with a total course load of not less than 60 ECTS, as well as the completion of a term project.

About the Program

Kamu Hukuku Tezsiz Yüksek Lisans Programı, kamu hukukunun temel alanlarında ileri düzey bilgi ve uygulama becerisi kazandırmayı amaçlayan bir lisansüstü eğitim programıdır. Program kapsamında Anayasa Hukuku, İdare Hukuku, İnsan Hakları Hukuku, Ceza ve Ceza Muhakemesi Hukuku, Uluslararası Hukuk, Vergi Hukuku, Hukuk Felsefesi, Hukuk Sosyolojisi ve Karşılaştırmalı Kamu Hukuku gibi alanlarda teorik bilgiyi uygulamayla destekleyen dersler sunulur. Öğrenciler, kamu hukukunun temel kavram ve kurumlarını daha derinlikli biçimde inceleme, güncel hukuki sorunları analiz etme ve mesleki uygulamada karşılaşılan uyuşmazlıklara çözüm geliştirme imkânı elde ederler. Program, tez yazımı yerine dersler ve dönem projesi aracılığıyla öğrencilerin bilgi ve analiz yetkinliklerini geliştirmeye odaklanır. Bu yönüyle programın amacı, kamu hukuku alanındaki güncel gelişmeleri takip edebilen, teorik bilgiyi uygulamaya aktarabilen ve mesleki pratiğinde uzmanlaşmış hukukçular yetiştirmektir.

About the Program

The Non-Thesis Master's Program in Public Law is a graduate program designed to provide advanced knowledge and practical skills in the main fields of public law. Within the framework of the program, courses are offered in areas such as Constitutional Law, Administrative Law, Human Rights Law, Criminal Law and Criminal Procedure, International Law, Tax Law, Philosophy of Law, Sociology of Law, and Comparative Public Law, combining theoretical knowledge with practice-oriented perspectives. Through these courses, students are enabled to develop a deeper understanding of the fundamental concepts and institutions of public law in greater depth, analyze current legal issues, and develop solutions to disputes encountered in professional practice. Rather than requiring the preparation of a master's thesis, the program emphasizes the development of analytical and professional competencies through coursework and the completion of a term project. Accordingly, the program aims to educate legal professionals who are capable of closely following current developments in public law, effectively integrating theoretical knowledge with practice, and advancing their professional expertise in the field.

Program Educational Objectives

Kamu Hukuku Tezsiz Yüksek Lisans Programı, öğrencilerin kamu hukukunun temel disiplinlerinde ileri düzey kuramsal ve uygulamaya dönük bilgi edinmelerini, güncel hukuki meseleleri çok boyutlu biçimde değerlendirebilmelerini ve mesleki yetkinliklerini geliştirmelerini amaçlamaktadır. Program; Anayasa Hukuku, İdare Hukuku, İnsan Hakları Hukuku, Ceza ve Ceza Muhakemesi Hukuku, Uluslararası Hukuk, Vergi Hukuku, Hukuk Felsefesi, Hukuk Sosyolojisi ve Karşılaştırmalı Kamu Hukuku gibi kamu hukukunun başlıca alanlarında kapsamlı bir akademik birikim kazandırmayı hedeflemektedir. Programın temel amaçlarından biri, öğrencilerin kamu hukukuna ilişkin klasik ve güncel tartışmaları kavrayabilmelerini, hukuki normları yorumlama ve değerlendirme becerilerini geliştirmelerini ve karşılaşılan hukuki sorunlara analitik, eleştirel ve çözüm odaklı bir yaklaşımla yaklaşabilmelerini sağlamaktır. Bu doğrultuda öğrencilerin yalnızca mevzuat bilgisiyle yetinmeyip, yargı kararlarını, doktrindeki görüşleri ve karşılaştırmalı hukuk verilerini birlikte değerlendirerek daha derinlikli ve çok yönlü analizler yapabilmeleri amaçlanmaktadır. Tezsiz bir program olması sebebiyle program, öğrencilerin özellikle mesleki uygulamada ihtiyaç duyacakları bilgi ve becerileri güçlendirmeye odaklanmaktadır. Bu kapsamda öğrencilerin hukuki muhakeme, problem çözme, yorumlama, yazılı ve sözlü ifade ile bilimsel çalışma yöntemlerinden yararlanma becerilerinin geliştirilmesi hedeflenmektedir. Dönem projesi ve ders çalışmaları aracılığıyla öğrencilerin belirli bir konuda araştırma yapabilme, kaynaklara ulaşabilme, bilgiyi sistematik biçimde değerlendirebilme ve ulaştıkları sonuçları akademik kurallara uygun biçimde ortaya koyabilme yeterliliği kazanmaları da programın amaçları arasındadır. Bunun yanında program, mezunların kamu kurumları, yargı teşkilatı, idari birimler ve diğer mesleki uygulama alanlarında ihtiyaç duyacakları ileri düzey hukuki analiz ve değerlendirme yetkinliklerini güçlendirmeyi hedeflemektedir. Böylece öğrencilerin kamu hukukunun teorik birikimini uygulama ile ilişkilendirebilen, ulusal ve uluslararası gelişmeleri takip edebilen, kamu hukuku alanındaki güncel sorunlara çözüm üretebilen ve mesleki yaşamlarında bu birikimi etkili biçimde kullanabilen yetkin bireyler olarak yetişmeleri öngörülmektedir.

Program Educational Objectives

The Non-Thesis Master's Program in Public Law aims to provide students with advanced theoretical and practice-oriented knowledge in the core disciplines of public law, to enable them to evaluate current legal issues from multiple perspectives, and to enhance their professional competencies. The program seeks to equip students with a comprehensive academic background in the principal fields of public law, including Constitutional Law, Administrative Law, Human Rights Law, Criminal Law and Criminal Procedure Law, International Law, Tax Law, Philosophy of Law, Sociology of Law, and Comparative Public Law. One of the main objectives of the program is to ensure that students are able to comprehend both classical and contemporary debates in public law, improve their skills in interpreting and evaluating legal norms, and approach legal issues with an analytical, critical, and solution-oriented perspective. In this respect, the program aims for students not only to acquire knowledge of legislation, but also to develop the ability to conduct deeper and more multidimensional analyses by considering judicial decisions, doctrinal opinions, and comparative legal data together. As a non-thesis program, it particularly focuses on strengthening the knowledge and skills that students will need in professional practice. In this context, the program aims to develop students' abilities in legal reasoning, problem-solving, interpretation, written and oral expression, and the use of scientific research methods. Through term projects and course work, the program also seeks to equip students with the ability to conduct research on a specific topic, access relevant sources, evaluate information systematically, and present their conclusions in accordance with academic standards. In addition, the program aims to strengthen the advanced legal analysis and evaluation skills that graduates will need in public institutions, the judiciary, administrative bodies, and other professional fields of practice. Accordingly, it is envisaged that students will be trained as competent individuals who are able to relate the theoretical foundations of public law to practice, follow national and international developments, produce solutions to current issues in the field of public law, and use this knowledge effectively in their professional lives.
